SCOTTISH PHYSICIANS' CLINICAL STANDARDS AND AUDIT COLLABORATION

Since May 1999, the Scottish Royal Colleges of Physicians (the Royal College of Physicians of Edinburgh (RCPE) and the Royal College of Physicians and Surgeons of Glasgow (RCPSG)) have worked with the Scottish Physicians' Specialist Societies to coordinate clinical audit and standard setting activities in adult hospital medicine through their Bicollegiate Physicians' Committee for Clinical Standards and Audit. This collaborative venture aims:

- to provide an information network for physicians and other health care professionals involved in clinical audit and standard setting in Scotland;
- to liaise with other relevant organisations; and
- to develop clinical audit standards for use in adult hospital medicine in Scotland.

To date, these have been developed in six key areas:

- 1. general medicine
- 2. geriatric medicine
- 3. cardiovascular medicine
- 4. respiratory medicine
- 5. stroke
- 6. diabetes

This selection was made on the following criteria:

- high volume hospital medical services (acute and outpatient) led by hospital physicians;
- health service priorities in Scotland (coronary heart disease, stroke, cancer (of which lung cancer is that most frequently presenting to hospital physicians));
- development of SIGN and other UK evidence- and experience-based clinical guidelines by Royal Colleges of Physicians, Physicians' Specialist Societies and NHSrelated bodies; and
- Scottish/UK experience in clinical audit.

These pilot clinical audit standards have been developed by the Scottish Physicians' Joint Specialty Groups in each of the six key areas, comprising representatives of RCPE, RCPSG, relevant Scottish Physicians' Specialist Societies, the Royal College of General Practitioners (Scotland) and the Faculty of Public Health Medicine (Scotland). An application for funding of national medical audits using selected standards from this programme is currently in preparation; meanwhile, their evaluation in local medical audits is encouraged.

The proposed standards have been subjected to wide peer review, and have been approved by RCPE and RCPSG Councils. However, we would welcome the views of Fellows and Collegiate Members on particular draft standards, or on the programme more generally.
